

How it Works





Click on Upload File or drag and drop a file.

Single and/or multi-page documents can be scanned and uploaded using an iOS device.

Simply click the + symbol in Digital Vault on the mobile app, and follow the instructions.*

Select Document Type (e.g., Tax Document, Legal Document).

Click on Upload.


Your file will be reviewed by your Morgan Stanley Team.

Name the folder.

Click on Save.

Click on the ellipsis next to a file or folder and select **Download**.

COMMENTS

Add Comments to a Document.

Click on the ellipsis next to a file or folder and select **Comments**.

MOVE FILE OR FOLDER

Click on the ellipsis next to a file or folder and select **Move**. Choose a destination folder and then click on **Move**.

F DELETE FILE OR FOLDER

Click on the ellipsis next to a file or folder and select **Delete**. Confirm by selecting **Delete** again in the next window.

Note: Once a document is deleted, it cannot be recovered.
