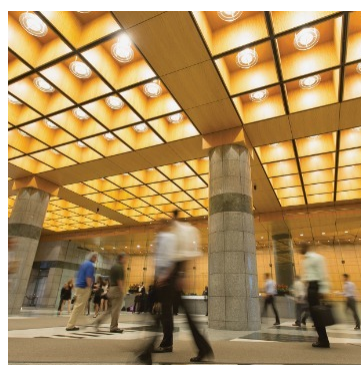

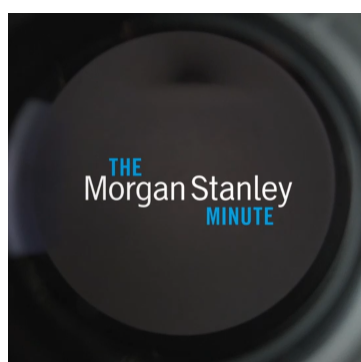

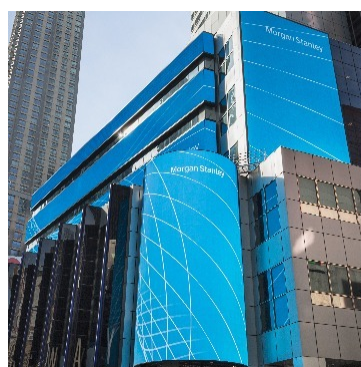


### March GIC On the Markets
