Happy November! Below you can find some resources and insights regarding the latest market data, some key tips to start your road to retirement, and some timely recipes for thanksgiving.

Market Commentary:

We are now in full swing of many important developments as we come closer to closing out 2024. Third quarter earnings are a bit mixed. We have banks reporting relatively healthy spending and capital markets activity. The Tech earnings have been positive but they are coming off of really big expectations from past quarters, leading their share prices to fluctuate. So far large-cap corporations are growing at an annualized profits of ~6.7%<sup>1</sup>, but if we subtract the Magnificent 7, annualized profits are about 2%<sup>2</sup>. Expectations have been 10% in the fourth quarter (reporting to start in January) and 15% for all of next year<sup>3</sup>. Will earnings start to reflect higher to meet expectations?

On top of this we have a meeting from the FED, inflation, economic, labor data, and the US election. Feel free to reach out if you have any questions or concerns.
