

## Historically, Those With Bad Timing Still Beat Treasuries...

Looking back from 01/02/1975 to 09/06/2023 had you picked the very worst day to invest in stocks and held on for 15 years, you still would've done better then had you invested in short-term Treasuries. Rates today are at, or close to, their highest level in 20 years, but 80%+ of periods would still have outperformed even those rates.
