





## Shutdowns have historically been immaterial to the stock market

The average performance 7 days prior to shutdowns through the 7 days after shutdowns have resulted in a whopping +0.07% with 50% of them being over 1% and 50% being under 1%. Washington for the most part does not influence the stock market as much as the people on TV would lead you to believe.
