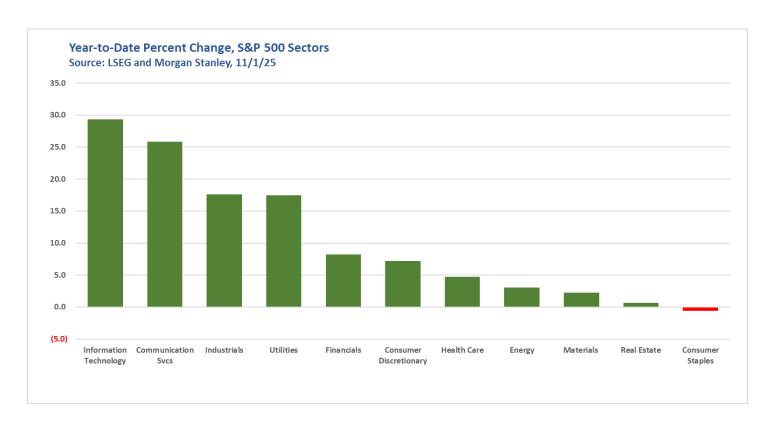

Markets and The Economy:

October was kind to investors for a change and major US equity indices continued to demonstrate strength. The graph below shows more detail on how US market gains are being derived. Information Technology, Communications Services, Industrials, and Utilities all enjoyed double digit gains this year. Every other sector of the S&P 500 though has returned less than 10% year to date. The defensive Consumer Staples sector is flat on the year.

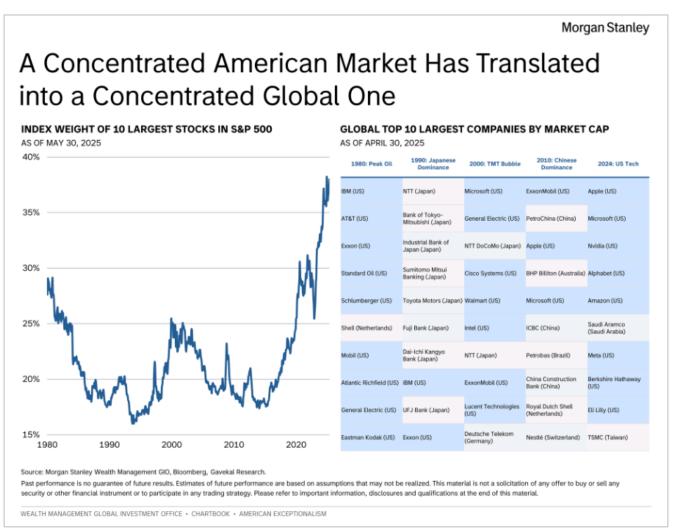
We think the driver within the top four sectors is largely due to the combination of computing hardware, artificial intelligence (Ai), and the power systems needed to run them. The investment dollars flowing throughout these sectors have been robust for the past couple years. Spending within these sectors is showing few signs of slowing. The returns however remain concentrated atop the S&P 500 market cap weighted index.



While the market-cap-weighted S&P 500 index has posted a YTD return of more than +17%, the equal-weighted S&P 500 index's return is less than 9% on the year. The Russell Value indices have also posted YTD returns below 10%. The market's advances have largely been driven by growth issues in tech, communications, and industrials.

We pointed out before that the growth of the largest companies in the S&P 500 index has concentrated much of the value at the top of the index. The graph at left in the chart below (1) shows that the ten largest companies in the index now represent nearly forty percent of the index's value. History though reminds us of why we need to be careful of recency bias, which is the proclivity to assume that the future will mirror the past.

The right side of the chart shows (1) the top ten largest companies in the world ranked by market capitalization for various past decades. In the 1980's, US petroleum companies dominated the list. In the 1990's, Japanese banks were among the world's most highly valued. In the 2000's, technology and telecommunication companies dominated. In the 2010's, only three US companies were in the top ten. Today, most of the top ten are US technology companies. We think it is prudent to consider the possibility that today's top ten companies – which were largely not among the top ten in previous decades – may not be among the top ten five to ten years from now.



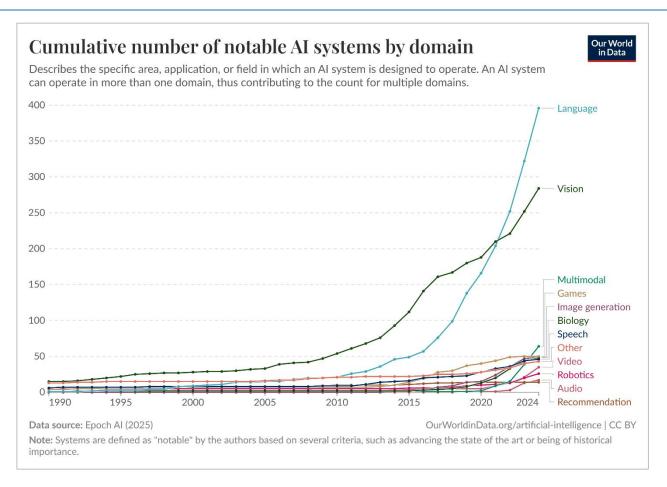
Energy prices tumbled this year while precious metal prices soared. Plotted below is a graph showing the ratio of gold to oil prices for the past twenty years. While gold prices have soared to record highs this year, the ratio was still far higher during COVID. It is our observation that the ratio spikes during periods of elevated uncertainty. We see spikes during the 2007-2009 financial crisis and again during the 2015 to 2016 election campaign. The COVID pandemic tripled the ratio, although that was due in part to a temporary but deep collapse in oil prices.



We think the current spike is being driven by soaring federal debt and US tariff unknowns. Oil supplies are also more abundant, and they have helped restrain oil prices. For decades though the ratio ranged from 10 to 20, making spikes of 60 to 90 seem quite abnormal. Those who subscribe to the theory of central tendency – meaning that long term prices, ratios, and processes tend to follow historical long-term averages – would suggest that this ratio is unlikely to hold.

The Federal Reserve cut the Fed Funds rate another 25 bps in late October, marking its second cut of the year. (2) The FOMC statement about the cuts pointed to moderating economic and jobs growth as the reason to reduce rates again. We find ourselves in agreement with this logic given that the Fed pushed rates up so swiftly and sharply in their recent rate hike cycle. Inflation data that we monitor suggests that inflation rates continue to moderate which also gives the Fed more room to ease rates.

For now, technology remains in the equity investors driver's seat. The explosion of artificial intelligence models and systems cannot be overstated and is shown via the chart at the top of page four. (3) Ai systems for language and vision are growing the most rapidly but we note that the third fastest grower is multimodal systems. All the sectors shown though are growing and we see no near-term evidence of slowing system development and growth.



Some people have begun using the word 'bubble' to describe markets. We have read negative reporting that suggests that meaningful Ai investment returns are not there yet. We are not in the camp though that calls this a bubble. There is a difference in our view between 2000's profitless dot.com companies and the now highly profitable companies atop the technology sector.

As users of Ai now within our daily work, we already see clear evidence of its benefits. For us, Ai adds efficiency and frees time for more important work. Tasks that once took hours, such as manually entering statement data for a client's external account, can now be completed in minutes with an Ai scan of a statement PDF. The concept is simple enough, but the time benefits should be substantial over the long term.

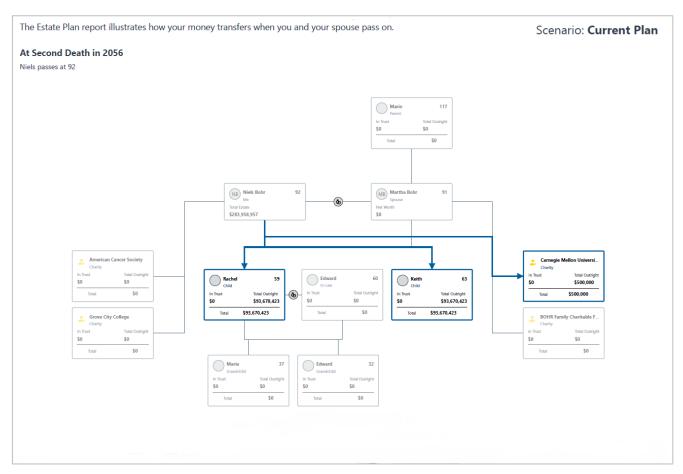
Uncertainty will never go away. It is the reason the gold to oil ratio is currently above 60. People have long worried about job destruction driven by technology advances and fretted over the meaning of new technology adoption. We are sure that horse-driven carriage drivers feared the automobile. Telephone operators had reason to fear the internet search engine. But employment opportunities grew in new fields and jobs were created that nobody ever imagined.

We believe that those who insist some sort of societal Malthusian limit is about to be reached may again be missing the big picture. We still believe the opportunities outweigh the threats.

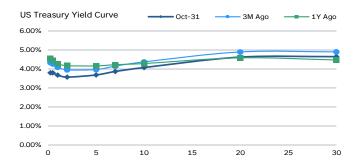

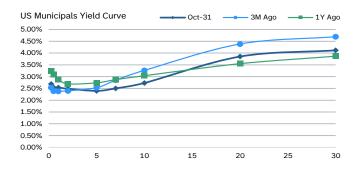

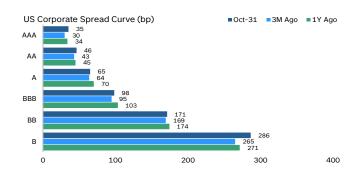
