# Indigo Environmental Impact Strategy

#### **MODEL OBJECTIVES**

The Indigo Environmental Impact Strategy (EIS) is a broad Environmental, Social and Governance (ESG) strategy with thematic elements in renewable energy and clean technology.

As impact-oriented metrics increase in quality and availability, investors are able to take actionable steps toward building a more positive, resource-efficient economy.

Our portfolio seeks to achieve positive environmental and social impact and competitive risk-adjusted returns over the long-term.

#### **INVESTING IN ENVIRONMENTAL IMPACT**

ESG factors consider how a company does business, meaning the sustainability and societal impact of its business operations.

Beyond how a company does business, we also look at what type of business the company is in. This means more actively seeking exposure to companies whose business models revolve around creating positive environmental impact.

We aim to invest in companies aligned with solving environmental issues and/or proactively adjusting to climate change.

#### **RESEARCH PROCESS**

Our process is designed to generate competitive riskadjusted market returns as well as positive environmental and social impact. We search for companies rated overweight or equal weight by MS&Co research that are actively seeking to mitigate the risks associated with ESG concerns, rated BB or higher, as measured by MSCI ESG.\*

While we believe broad-based ESG data provides valuable insight to evaluate a company, additionally we seek concentrated exposure to leaders in specific ESG themes. Specifically, this portfolio strives to invest in companies that provide environmental solutions and reduce natural resource stress.


