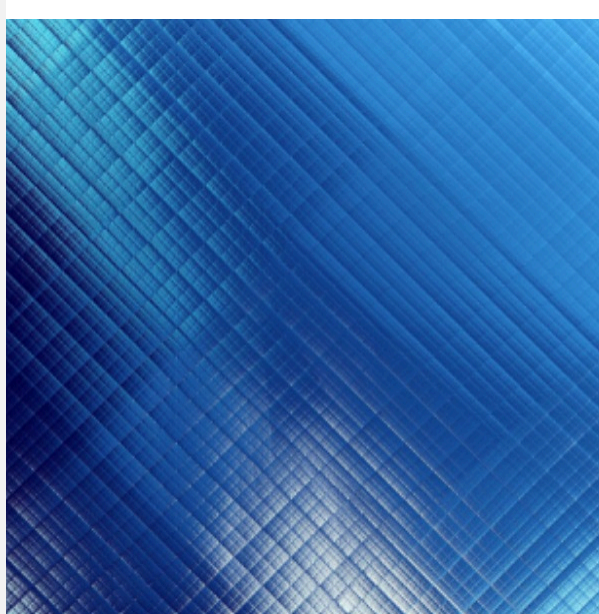
I got fired from my job at the bank today. A customer asked me to check her balance, so I pushed her over

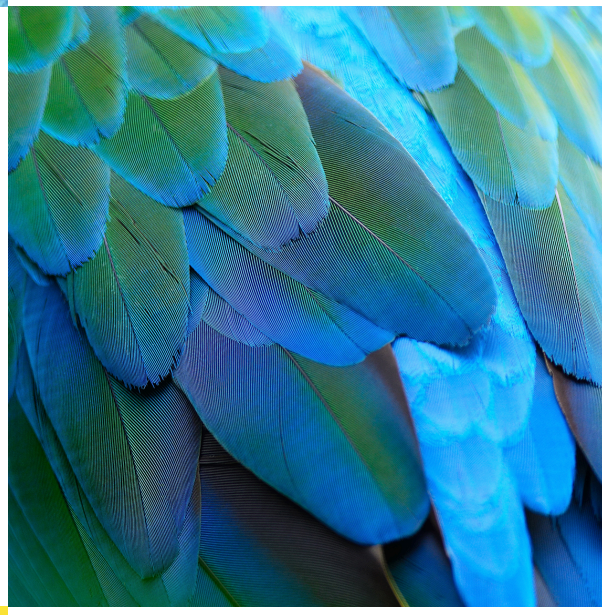

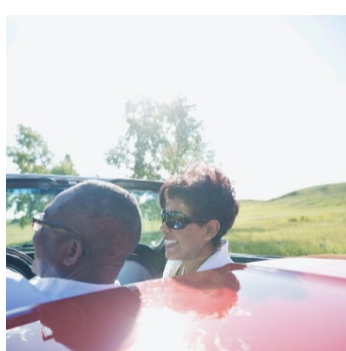
